### INTRODUCTION

Please explain how the LEA will determine its most important educational needs as a result of COVID-19. (3000 characters max)

The Sullivan County School District has surveyed students, families and staff about internet, internet service and technology. Teachers made personal contact via phone calls to ask if they preferred paper-based instruction as well. With the combination of parent input and teachers' instructional strategies, paper packets for students will be created for those that do not have adequate internet access and prefer paper-based instruction; community internet-based access centers as well as hotspot access will be announced and shared with families throughout the county. We have re- allocated our special education and Title services so they are strategically aligned with the students who need the greatest support. They will also be moving forward with all compliance issues around special education procedures and processes. Administrative assistants and support teachers will reach out to any students who do not attend live sessions or from whom their teachers have not heard. Due to the nature of our rural, remote county, there are those that live where internet resources are inadequate, inaccessible, or unavailable. Therefore, until this can be fixed, as a district, we will always struggle to go total remote distance learning with fidelity for all of our students so community effort has been given to provide places such as libraries, parking lots etc. for families to travel to get internet access.

Please explain the LEA(s) proposed timeline for providing services and assistance to students and staff. (3000 characters max)

The Sullivan County School District in grades K-12 will provide planned instruction for all students starting with the first day of the school calendar for 2020-2021. Teachers will offer new content and instruction in all content areas. All teachers will provide "Office hours" and support for students and their families at a variety of times. Teachers will meet and plan with their grade-level or content peers and colleagues to collaborate. Teachers will participate in professional learning opportunities and weekly "check-ins" with their building administrators.

Sullivan County School District is a 1-to-1 Chrome Book device in all grades K-12. There will be times when paper worksheets are more appropriate. Planned Instruction opportunities, parent communications, and worktime availability for teachers are on individual teacher websites located on the District's web site. Events where families do not have internet access, planned instructions opportunities through paper packets will be distributed to the home by school buses and mail. Students without internet access will receive support through landline and cell phone calls from faculty and administration. Distribution of devices and accessories for new students to the district will be handled through the administration of the building when the student enrolls. Technology support for devices will be provided by the district via a 'tech request' hotline.

Please describe how the LEA intends to assess and address student learning gaps resulting from the disruption in educational services. (3000 characters max)

Planned Instruction of subject content materials will be delivered to all K-12 students attending Sullivan County Schools. In addition, opportunities for teachers and students to make contact on a regular basis as we navigate these undefined times. We are a one-to-one device school district in grades K-12. However, due to the nature of our rural, remote county, there are those that reside where internet resources are inadequate, inaccessible, or unavailable. For those families we are providing paper-based instruction.

Please describe the LEA(s) proposed procedures for evaluating local COVID-19 impacts in relation to education programming and delivery. (3000 characters max)

Areas of emphasis should include:

- Documenting learning loss associated with extended school closure;
- Outlining the development of local continuity of education plans over the course of emergency response efforts; and
- Detailing supports for vulnerable student populations and families.

Sullivan County provides Chromebooks for all students in grades K through 12. The district will continue to use the online educational platforms Google Classroom and Seesaw that we use during the regular school year. Teachers and students are familiar with these platforms. Teachers are able to use Google Meets applications to virtually meet with students. In addition, staff members will be using their personal phones to communicate. Teachers will make phone calls home to check in with their students and ask if they have any questions concerning the work they are doing; it is to give the personal touch that is missing from not attending school. While our intent is to deliver as much of the activities virtually, paper packets will be provided as requested, particularly for families without internet access. K-12 Teachers will plan, design, and deliver instruction daily to their students. They will provide additional supports as needed and remain in contact with their students. Teachers will reach out to students via phone, email, ClassDojo, Google Meets, etc. if they miss more than two sessions in a row. Sullivan County

Students are expected to participate in sessions provided by their teachers, watch recorded lesson provided by their teachers, and complete activities as follow-up.

In the 2020-2021 school year, the Sullivan County School District will 1) Stay connected with students to attain a greater understanding of student social, emotional, and mental health needs through various forms of communication. 2) Engage students in learning opportunities in all content areas and 3) Maintaining flexibility with our students and staff to ensure all students have equitable access to the content to deepen and extend thinking in all content areas. Primarily the investment of CARES funding will provide the services of a Coordinator of Virtual Curriculum and Technology who will provide support to all of our District Faculty ensuring that our programs can be provided by our Griffin Virtual Academy. The District will determine local and state funding available to ensuring continuation of the program for the 2021-2022 school year and beyond.

Special education teachers and staff will work with regular education teachers and families to meet students' needs to the maximum extent possible. IEP and 504 plan meetings will be held at least annually either in person or virtually. Accommodations listed in students' IEPs or 504 plans will be followed and revisions will be made to plans as deemed appropriate by IEP and 504 teams. If parents have questions or concerns, they are encouraged to contact their students' teachers and the supervisor of the department. Teachers will follow students' EL supports as described in the students' Individual English Language Learner Plans. If parents have questions or concerns, they are encouraged to contact their students' teachers and the supervisor of the department. Students that are identified as gifted will continue to receive the enrichment or acceleration opportunities that are listed in their GIEPs. If revisions to plans need to be made, GIEP teams will make those decisions individually. If parents have questions or concerns, they are encouraged to contact their students' teachers and the supervisor of the department.
